

## **Registration's conditions.**

1. The organizer offers the registration's service and payment of registration fees and tickets without a fee for the physical person (hereinafter Participant), including using his credit card.
  - 1.1. Making the payment on the website, the Participant agrees to all conditions listed below.
  - 1.2. If the Participant does not accept the conditions of the registration, he is not allowed to register and pay registration fees and tickets and participate in the event.
  - 1.3. This Condition contains all the essential terms of sale and refund.
  - 1.4. The refund of registration fees and tickets is possible only in case of cancellation or postponing of the event and upon presentation by the Participant of the identity document indicated in the registration documents.
  - 1.5. The participant is considered registered only after paying the registration fees and paying it within the time limits set by Organizer.
  - 1.6. The Participant is responsible for the accuracy of the information specified in registration forms. This information is filled out only once and can not be changed in the future.
2. The Participant gives his consent to the processing of personal data by the Organizer and confirms that giving such consent he guided by his own will and his interest.
3. Consent to the processing of personal data apply to the following information: name, surname, patronymic, year, month, date and place of birth, address, occupation, photography, incomes and any other information related to the identity of the Participant's available or known at any given time to the Organizer (hereinafter - personal data).
  - 3.1. This consent is granted for the implementation of any action with respect to personal data of the participant, including, without limitation: the collection, systematization, accumulation, storage, clarification (update, change), use, distribution (including transmission), depersonalization, blocking, destruction, cross-border the transfer of personal data as well as perform any other actions with personal data, taking into account existing legislation.
  - 3.2. This consent may be revoked by sending Participant written notice to the Organizer.
  - 3.3. Personal data mayl be processed by the Organizer with the use of automation or without the use of such assets using the following basic ways (but not limited to): storage, recording on electronic media and storage, listing, labeling.
4. The organizer has the right to unilaterally establish and modify the list and the cost of additional services, the schedule of event, the rules of event and opening hours.
5. The Organizer is not responsible for:
  - 5.1. For damage caused to life, health or property of the Participant which is the result of the late provision and / or untimely provision the reliable information about the state of health; and/or in case of violation or improper performance of activities by the Participant the Rules of event and/or provisions (regulations) of physical education, sports and recreation activities and/or safety rules when using the Services or Additional services; for damage caused to health or property caused by Participant's own actions and/or inactivity and/or caused by actions of third parties.
  - 5.2. For loss or damage to personal belongings, including left in the locker room or other room in which organized the event.
  - 5.3. For technical inconveniences caused by the conduct of the authorized organizations seasonal prevention, construction and repair and other works, as well as emergency situations arising through no fault of the Organizer.
